<b>Description</b>	<p>The course will teach students to apply basic statistical analysis and analytical epidemiologic methods using the R statistical computing. R is not only a free statistical software but also a language and environment for statistical computing and graphics. R is highly extensible and runs on a wide variety of UNIX platforms, Windows and MacOS.</p> <p>During this module, the emphasis will be on learning by doing. Practice material and data will be grounded on actual research questions and are intended to illustrate the kinds of issues that often arise when practicing statistics and epidemiology. Students will be encouraged to apply the material to their own research interests and epidemiological analyses. Each session is a combination of didactic lecture and hands-on practice. Students will conduct epidemiological analyses on actual data sets, and learn the importance of data preparation and cleaning, descriptive analyses, as well as how to conduct basic statistical analyses including regression analyses.</p>
<b>Prerequisites</b>	Students are assumed to be familiar with elementary statistical methodology (such as descriptive analysis, hypothesis testing, etc)
<b>Course learning objectives</b>	<p>The course will familiarize students with the programming skills necessary to:</p> <ul style="list-style-type: none"> <li>• Use the R statistical computing environment to enter, read, clean, organize, index and manipulate data in R.</li> <li>• Analyze rate, ratio and risk data in R using matrices, arrays and data frames.</li> <li>• Apply R functions and packages for regression models to analyze epidemiologic data.</li> <li>• Apply base graphics and ggplot2 to explore, plot, and present analyses.</li> <li>• Understand how R can be extended with function.</li> <li>• Save analysis for reproducible research</li> </ul>

<b>Course requirement</b>	Students have to come to class with a computer with the software R and RStudio installed (Instructions for installation will be send one week before the course)

<p><b>Grading and assessment</b></p>	<p><b>In-class Exercises: 20%</b> Starting the second day, the morning sessions will begin with a quiz related to the previous day. The quiz will be proposed via the EHESP REAL platform.</p> <p><b>Final Project: 80%</b> At the beginning of the week the students will receive a dataset on a public health issue that they will have to analyze using R. They will be able to start working on the data at home and will have the last day of the week to finalize the analysis. The objective is to</p> <ul style="list-style-type: none"> <li>• Describe the data (present summary statistics and graphs)</li> <li>• Investigate the factors associated with public health issue</li> </ul> <p>Students are required to submit a final paper and the associated R code presenting their analysis. The assignment is intended to allow the student the opportunity to demonstrate his or her ability to conduct preliminary analyses of an epidemiologic problem using R. The final paper is limited to 5-pages.</p> <ul style="list-style-type: none"> <li>• Cover Page: Title, student's name, Affiliations (if any) and abstract or overview of the vignette including methods and results.</li> <li>• Introduction: What is known about the epidemiological topic, what is not known, why it is important.</li> <li>• Approach: Analytic design or method to be presented, including variables and their roles in the analysis (explanatory, confounding, interaction, etc...). The main R packages used with version.</li> <li>• Results: Narrative walkthrough of the analysis with graphics and table of results.</li> <li>• Discussion: Including limitations, conclusions, possible next steps.</li> <li>• References: Limited to 15 citations (not counted toward pagelimit).</li> </ul>
<p><b>Course policy</b></p>	<p><b>Attendance &amp; punctuality</b> <b>Regular and punctual class attendance is a prerequisite for receiving credit in a course.</b> Students are expected to attend each class. Attendance will be taken at each class. The obligations of attendance and punctuality cover every aspect of the course: - lectures, conferences, group projects, assessments, examinations, as described in EHESP Academic Regulations <a href="http://mph.ehesp.fr">http://mph.ehesp.fr</a> EHESP Academic Regulation Article. 3). All supporting documents are provided to the end-of-year panel.</p> <p>Students who miss class are responsible for content. Any student who misses a class has the responsibility for obtaining copies of notes, handouts and assignments. If additional assistance is still necessary, an appointment should be scheduled with the instructor. Class time is not to be used to go over material with students who have missed class.</p> <p><b>Lateness:</b> Students who are more than 10 minutes late may be denied access to a class. Repeated late arrivals may be counted as absences (See <a href="http://mph.ehesp.fr">http://mph.ehesp.fr</a> EHESP Academic Regulation Article. 3 Attendance &amp; Punctuality)</p> <p><b>Maximum absences authorized &amp; penalty otherwise</b> Above 20% of absences will be designated a fail for a given class. The students will be entitled to be reassessed in any failed component(s). If they undertake a reassessment or they retake a module this means that they cannot normally obtain more than the minimum pass mark (i.e. 10 out of 20)</p> <p><b>Exceptional circumstances</b> Absence from any examination or test, or late submission of assignments due to illness, psychological problems, or exceptional personal reasons must be justified; otherwise, students will be penalized, as above mentioned. Students must directly notify their professor or the MPH academic secretariat before the exam or before the assignment deadline.
