Description	The goal is to provide knowledge and skills in performing and interpreting the results of multivariate analyses and of multidimensional exploratory methods including principal component analysis, multiple correspondence analysis and clustering analyses. More specifically, multidimensional analyses will be view as a statistical methods used in public health to analyse high-dimensional data sets. These technics are particularly adequate to synthetizing variables highly correlated and eliminating collinearity problem in multiple regression (i.e. creation of a composite index) or to generate groups of individuals with similar underlying patterns. Complementarity between modelling approaches and multidimensional exploratory analysis will be presented. Each day is designed to alternate between lectures, exercises and computer lab using R software.
